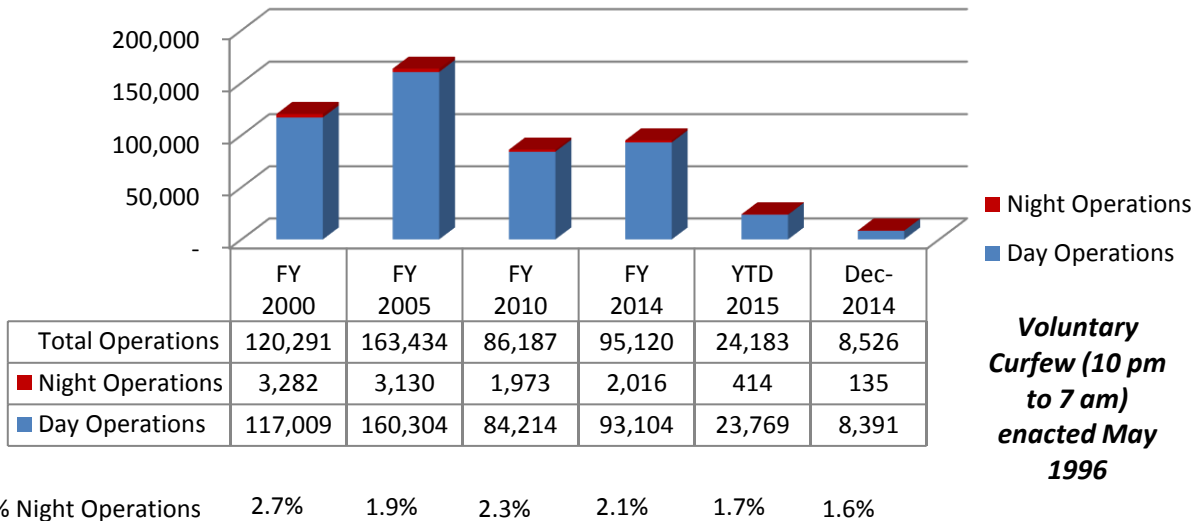
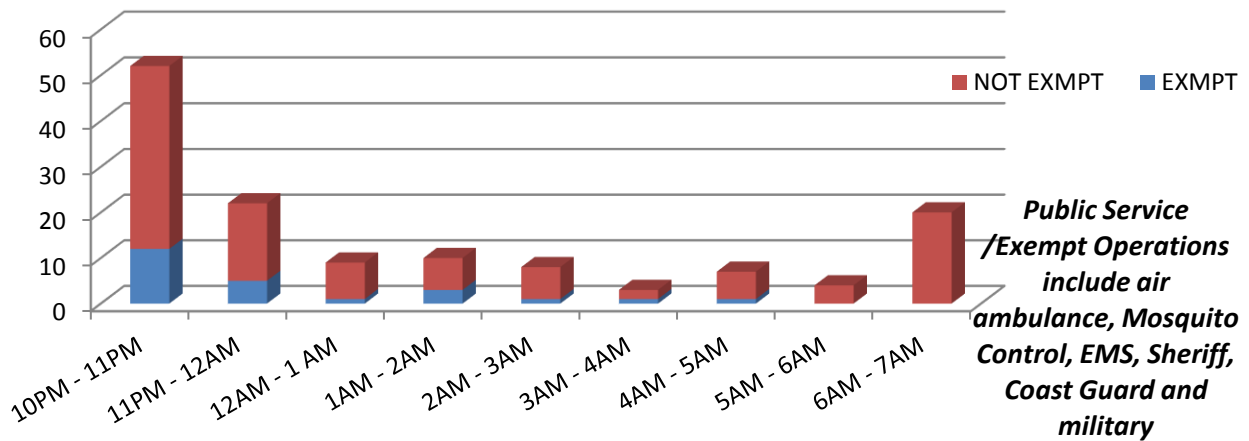

Pursue noise disclosure to potential residents

Continuing: Publicize, promote, and assess noise abatement procedures

Complete and publish flight procedures - delayed/on hold per FAA on 3/6/2014
