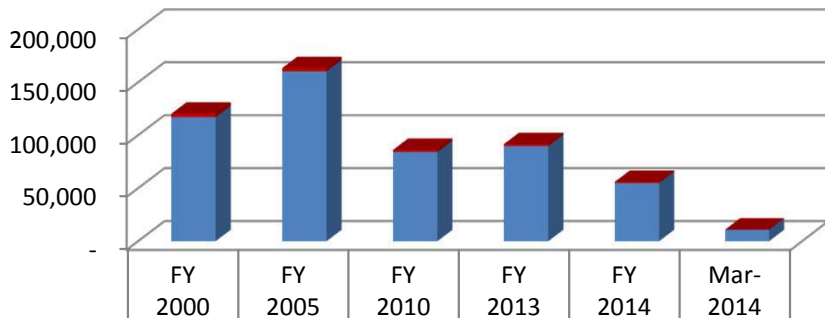

Day and Night Operations Annual & Current Month

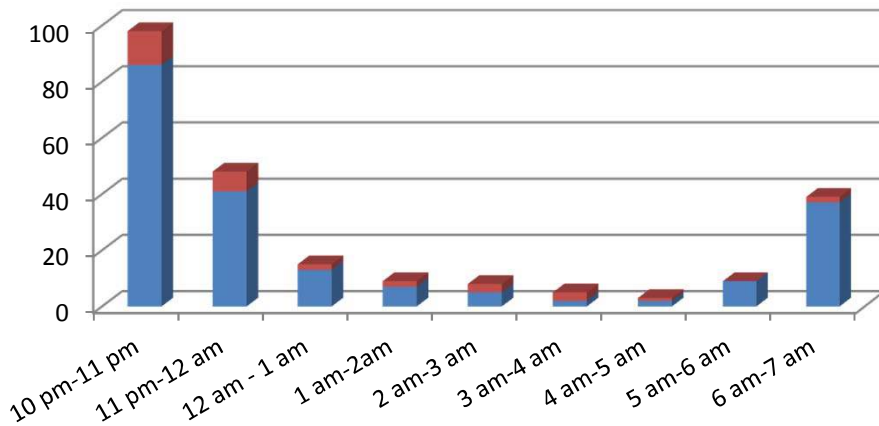
