1. **Interviews and Rankings of Responses to Request for Proposals for Land Leases for Development of North Quadrant Parcels 1 and 2**

ACTION REQUESTED: Interview the two (2) respondents for each parcel, establish a rank order for each parcel and authorize the Executive Director to enter into land lease negotiations with each of the top-ranked firms.

BACKGROUND: On September 28, 2018, a Request for Proposals (RFP) was issued to solicit proposals from qualified parties interested in the lease of land parcels 1 and/or 2 in the north quadrant of the airport for development of high-quality commercial aeronautical services to serve the public. The RFP was publicly advertised and posted to our website. Potential respondents were provided an opportunity to pose questions and request additional information through October 17, 2018. Responses were published in the form of addenda to the RFP.

Proposals were due on October 30, 2018. Two (2) submittals were received for each parcel and were determined to be responsive to the RFP. The submittals from the parties below are attached:

Parcel 1

- Marco Hangars, LLC
- Naples Jet Center

Parcel 2

- Marco Hangars, LLC
- Quality Enterprises USA, Inc./APF Development IV

In accordance with public procurement requirements, potential respondents were provided with the criteria by which their proposals would be evaluated, which are:

- Use of Premises
- Quality of Development
- Proven Record of Success
- Financial Capacity
- References

- Proposed Lease Terms
- Professionalism
- Presentation

Descriptions of each of these criteria are included in Section VIII. of the RFP, which can be accessed on our website at (copy link into your search bar):

In the event that two (2) or more proposals for the same parcel are considered equally desirable, the RFP specified that preference would be given based on the following criteria:

- Higher-quality construction materials, methods and finishes
- Higher initial rental rate

The first 10 minutes of the meeting will allow time for Commissioner comments and questions for staff regarding the RFP and selection process followed by respondent presentations, Commissioner questions and discussion.

After all presentations, the Board will be asked to provide a ranking of the respondents for each land parcel. With Board approval, staff will work with the top-ranked respondents and Authority legal counsel to negotiate lease agreements. The resulting agreements will be presented to the Board for approval at a future meeting.

COMMUNICATIONS PLAN: The respondents will be notified of the final ranking, and the results will be posted on our web site.
