

**Minutes**  
**January 31, 2019**  
**Consultant Selection Committee**

**A. ROLL CALL**

Meeting was called to order by Consultant Selection Committee Chair Lenhard at 10:44 a.m. in the Airport Office Building, 2<sup>nd</sup> Floor Conference Room. Also present were Commissioner Rideoutte, Committee Member; and Commissioner Messer, who opted in.

Staff and Legal Counsel present were Mr. Rozansky, Mr. Owens, Ms. Terrill, Mr. Keith, Ms. Jackson, Ms. Snyder and Ms. Menard.

**B. PLEDGE OF ALLEGIANCE**

Chair Lenhard led the Pledge of Allegiance.

**C. AGENDA**

There were no changes to the agenda.

**D. DISCUSSION ITEMS**

Ms. Jackson provided introductory comments and stated that the first respondent to be interviewed would be Harris Miller Miller and Hanson Inc. (HMMH), followed by Environmental Science Associates (ESA).

**1. Interviews and Rankings of Qualified Respondents for Noise Consultant Services Request for Qualifications**

**a. HMMH**

Ms. Mary Ellen Eagan, President and C.E.O., Project Manager and Principal-in-Charge of HMMH, provided a brief background of her firm. She introduced her team of Ms. Katherine (Kate) M.S. Larson, Assistant Project Manager, and Ms. Yvonne McClellan, Community Outreach Specialist from Quest Corporation of America. Ms. Eagan shared HMMH's mission and provided an overview of their primary work in the transportation industry, specializing in aviation and noise services. She outlined a few differentiators that adds value to their offering and highlighted their technical and industry expertise. Ms. Eagan reviewed their organization chart which included representatives from HMMH, Quest Corporation of America and Avcon. Ms. Larson provided an overview of their approach to the Part 150 study, reviewed the noise contours from previous noise studies in Naples and the major project milestones and strategies for the study. Ms. McClellan gave a brief background of Quest Corporation of America and their strategy for public engagement. Ms. Eagan presented a possible project schedule.

Ms. Eagan summarized future goals for the Noise Mitigation Program at Naples.

A question and answer period followed.

Vice Mayor Price commented regarding the 17 percent increase in operations and the expected five-year growth forecast as reported at the January 30<sup>th</sup> Joint NAA and NCC Workshop Meeting. He expressed concern that the Part 150 study measures the decibels of noise without assessing the frequency of operations and the impact that has on the quality of life. Mr. Rozansky responded that the modeling encompasses operations averaged over an annual basis.

**b. ESA**

Mr. Steve Alverson, Senior Vice President and Project Principal, of ESA introduced himself and his colleagues, Mr. Michael Arnold, Project Manager, and Ms. Yvonne Garth, Outreach Lead and President of Garth Solutions, Inc. Mr. Alverson provided a brief history of his firm and his qualifications.

Mr. Arnold introduced other members of their team and pointed out that ESA's mission statement aligns with Goal #2 of the Authority's Strategic Plan. Mr. Arnold presented their understanding of the project and outlined 14 CFR Part 150 opportunities, challenges, and the approach, as well as the Noise Compatibility Plan process.

Ms. Garth provided a brief overview of her firm and presented the public outreach program to provide a foundation for meaningful community input.

Mr. Arnold presented an overview of relevant success stories that were controversial at Southwest Florida International Airport, Fort Lauderdale International Airport and Martin County Airport. He provided examples of how ESA effectively communicated the challenges to the stakeholders, FAA, operators and pilots, resulting in the implementation of solutions that were beneficial to all parties.

Mr. Arnold reviewed ESA's on-call noise services. He highlighted aviation noise projects over the last 75 days and outlined future goals to advance our noise programs. He concluded the presentation by recapping why ESA should be selected as our consultant.

A question and answer period followed.

Chair Lenhard opened the discussion to evaluate the firms. Mr. Rozansky stated that both firms have the technical capability but that he was impressed with the relationships ESA has established at RSW and the work done with the RSW Tower. Commissioner Messer, Vice Chair Lenhard and Commissioner Rideoutte agreed with Mr. Rozansky's assessment and felt that ESA's approach to community interaction may be more effective, their presentation was superior and the synergy established during the master planning effort would assist with this project. Chair Messer added that it was important to recognize the significance of HMMH's contributions at the Naples Airport over the last 20 years.

There was consensus to rank the two firms as follows and to recommend the rankings to the full Board at the February 21<sup>st</sup> Regular Board Meeting:

- (1) ESA
- (2) HMMH


